

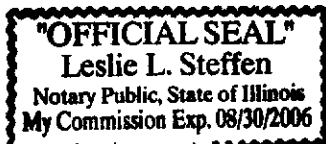



GOVERNMENT'S SECOND NOTICE REGARDING TENDERED DISCOVERY

Now comes the United States of America, by and through Patrick J. Fitzgerald, United States Attorney for the Northern District of Illinois, and provides notice to the Court and counsel that the following discovery materials have been tendered to counsel for those defendants who have appeared before the Court in connection with the above-captioned case:

Beginning on April 28, 2005, and on a continuing basis thereafter, the government has tendered to counsel for defendants James Marcello, Joseph Lombardo, Frank Calabrese, Sr., Paul Schiro, Michael Marcello, Nicholas Ferriola, Nicholas Calabrese, Anthony Doyle, Michael Ricci, Thomas Johnson, Joseph Venezia, and Dennis Johnson approximately 128 CD and DVD disks bearing discovery materials as shown on the discovery inventory (items 1 through 108) attached to this notice. The government anticipates that at the status in this matter scheduled for July 18, 2005, the government will provide items 109 through 120, an additional 12 CDs and DVDs.


These CDs and DVDs contain numerous audio and video recordings, as well as approximately 12,500 pages of material, and approximately 975 photographs.


